VI. Summarize Business conducted via Email

 - \circ $\;$ Agreed on the following process when owner is in street or visitor parking
 - For example, owner noted in violation on 4/1, on 4/2 "friendly" violation letter to be sent.
 - Cushion of 7 days between "friendly" and certified, so if on 4/10 they are again found in violation a meeting will be called so motion can be made to send certified letter
 - Upon sending of certified letter, member will be given 7 days to cure from the date of mailing
 - Immediate towing upon repeat violation after 7 days for the next 60 days, then cycle restarts
 - Tenants and visitors do not have the same rights, they are subject to immediate towing.
- Need to write proposed rules in bullet form to be sent to attorney. It should reinforce registration of member vehicles required to exercise member rights. Martin suggest changing the 1-15,16-31 rule to odd/even months and suggest red-line all of McLennan, Viaduct and Cavelier.

VIII. New Business

- Martin Salazar motioned to obtain quote for additional speed bumps. Karen Mueller seconded. Motion carried.
- Martin suggested we need to add color to the front/more flowers.
- Suggested we get quotes to complete conversion of lamps from halogen to led, to include the 4 at the gate.
